

Official Rules and Conditions

No Purchase Necessary. No purchase or payment of any money is necessary to enter. You may register for the drawing by visiting Arrowsmith Eye Institute xxxxxxxx xx, 20xx. Only one (1) entry per person is allowed. Duplicate entries may disqualify an entrant at the discretion of Sponsor. Entries must be completed and deposited in the designated drawing container at Arrowsmith Eye Institute before the drawing to be held on xxxxxxxx xx, 20xx. Entries will not be returned and all information written on the entries shall become the property of the Sponsor.
